Jersey Rowing Club – Boat Park Guidelines (2024)

Members Only:

- Unless approved in advance by the Committee, only the JRC and JRC Members can store (and use) boats in the Boat Park.
- Members must only rent their boats to other Members.

Allocating Racks:

- All rack allocations will be approved by the Committee before allocation.
- The registered boat owner is liable for the payment of the rental fee.
- The JRC recognise that Members may rent their boat to other members. Boat owners remain responsible for insurance and payment of rack fees.
- Members should endeavour to advise the Boat Park team in advance if purchasing a new boat or purchasing a boat off another Member.
- The Committee will not prevent upgrade to equipment and, once a rack fee is paid for the year, Members can change the boat on the rack provided it remains a suitable size for the rack.
- Racks can be transferrable with boat purchases if it is no longer required by the previous owner.
- If the Boat Park team are unable to make a rack available, Members will be placed on a waiting list.
- The JRC, the Boat Park team and Committee shall endeavour to be considerate to the needs of the Members when allocating racks.
- Subject to reasonable notice, the JRC reserves the right to change any Member's allocated rack. Waiting Lists:

The Committee will confirm / approve all new appointments to the waiting list.

- Only Members will be added to the waiting list.
- The Boat Park team will maintain a waiting list for each rack type, this will be provided to the Committee each month.
- Subject to reasonable notice and approval by the Committee, Persons with outstanding debts to the club will be removed from the waiting list.

Waiting List priority will be determined in the following order:

1. The Club's requirement for storing its own equipment is the priority and trumps all other requests.

- 2. The person who owns the least number of boats / rents the least number of racks in the boat park (part shares will be counted according to the boats ownership log)
- 3. The longest time on the waiting list (i.e. the earliest/oldest request is processed first)

Renting Racks:

- You must put an appropriate boat on an appropriate rack...(i.e. you must put quad on a quad rack, a doubles on a doubles rack, etc)
- Racks are considered to be rented to the Member. It is the Renters decision which boat is stored on their allocated rack (subject to appropriate use).
- All boats stored on Club premises must be appropriately insured and the Club
 reserves the right to request copies of evidence of this. If you intend to permit your
 boat to be used by other members please ensure your insurance allows this.
- Where members own more boats than rented racks, the Member can choose which
 of their boats can be stored in the Boat Park (subject to the appropriate use). The
 remaining boats must be stored offsite.
- Members who purchase a boat already in the boat park DO NOT automatically inherit the rack on which the boat was kept, but it can be transferred provided the previous owner no longer requires it and with approval of the Boat Park team
- Members who no longer own a boat, or who own less boats than racks they rent, will
 have their available rack reallocated by the Boat Park team with reasonable notice.
 However, the JRC will allow a grace period in the instance where a Member sells a
 boat to free up the rack for the Member's new boat.
- Racks that become available will be allocated according to the appropriate Waiting List.
- Subject to reasonable notice and approval by the Committee, Persons with outstanding debts to the club will have their boats moved to storage racks (and must pay the storage rack fee). The JRC reserves the right to initiate further proceedings at its discretion.
